

- PRIVACY INFORMATION FOR WEBSITE VISITORS -

This Privacy Policy is intended to describe the management of this site, with reference to the processing of visitor's personal data who consult it. This notice is provided pursuant to the GDPR 2016/679 Regulation - Personal Data Protection Code - to whoever is connecting to the SIGROUP INTERNATIONAL SRL corporate website and benefit of its web services starting from the address www.sigroup.info.

Website www.sigroup.info is owned by SIGROUP INTERNATIONAL SRL, which guarantees compliance with the legislation on the protection of personal data. Users / visitors must read this Privacy Policy carefully before submitting any type of personal information when completing the form on the site itself.

TYPE OF DATA PROCESSED AND PURPOSE OF TREATMENT

1) Internet browsing data

The computer systems and software procedures used to operate this site acquire, during normal operation, some personal data that are then implicitly transmitted when using Internet communication protocols. This information is not collected to be associated with identified interested parties, but by their very nature could allow users to be identified, through processing and association with data held by third parties. This category of data includes IP addresses or computers domain names used by visitors who access the site, addresses in URI notation (Uniform Resource Identifier) of the requested resources, request time, the method used in submitting the request to the server, the size of the file obtained in reply, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters related to the operating system and the user's computer environment. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site: apart from this possibility, the data on web contacts do not persist for more than seven days.

2) Data provided voluntarily by users / visitors

If users / visitors, connecting to this website, send their personal data to make requests through e-mail, this involves the acquisition by SIGROUP INTERNATIONAL SRL of the sender's address and / or other personal data that will be processed exclusively to respond to the request.

3) Cookies

The following provides information on the types of cookies installed by www.sigroup.info site, its purpose, and any other sites where the company is published.

What are cookies?

Cookies are text files created by some websites on the user's computer when accessing a particular site, with the purpose of storing and transporting information. Cookies are sent by a web server (which is the computer on which the visited website is running) to the user's browser (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) and stored on his computer; they are then sent back to the website at the time of subsequent visits. Some operations may not be performed without the use of cookies, which, in some cases, are therefore technically necessary. In other cases, the site uses cookies to facilitate and help the user's navigation or to allow him to take advantage of services specifically requested.

How do we use cookies?

The site does not use cookies to transmit personal information, nor are used so-called persistent cookies of any kind, or systems for tracking users.

Cookies used

1. Technical session / browsing cookies: the use of so-called session cookies (which are not permanently stored on the user's computer and disappear when the browser is closed), is strictly limited to transmitting session identifiers (consisting of random numbers generated by the server) necessary to enable a safe and efficient site navigation and its applications. The so-called session cookies used on the site avoid the use of other technologies that could compromise the privacy of users' browsing and do not allow the acquisition of personal identification data. They do not require consent.
2. Cookie Analytics: cookies installed to collect aggregate information, mainly statistical in nature (example: how long you stay on a web page, number of site visitors).
 - a. Analytical cookies of first part: similar to technical cookies as installed directly from the site you are visiting to improve their usability. They do not require consent.
 - b. Analytical cookies of third part: analytical cookies created and installed by third parties to analyze users' browsing in order to collect statistics on visits or to improve the content offer, show similar products and place targeted advertising on web pages. The system used is Google Analytics. The latter is a web analytics service provided by Google LLC ("Google"). Google Analytics, like other systems, uses cookies to allow the website to analyze how users use the site. The information generated by the cookie about the use of the website by the user (including the IP address) will be transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating the use of the website, compiling reports on website activity and providing other services related to internet use. Google may also transfer this information to third parties where required by law or where such third parties process the information on Google's behalf. Google will not associate user's IP address with any other data held by Google. In any case, the user may refuse to use cookies by selecting the appropriate settings on his browser, but this may prevent the use of all the website features. Since the IP address is clear, the use of these cookies requires the user's consent. By clicking on the "Continue" button in the banner or continuing to browse the site, user consents to the processing of data by Google in the manner and for the purposes set out above.

Managing cookie preferences

Consent to the use of cookies is given in one of the following ways:

- by clicking on the "Continue" button in the banner containing the short information, which appears when the user accesses the site;
- continuing to browse the site by accessing another area of the site or by selecting an item on the same page.

How to change the settings on cookies

Most Internet browsers are initially set to accept cookies automatically. This means that the user has the possibility, at any time, to set his browser to accept all cookies, only some, or to reject them, disabling their use by the sites. In addition, the user can normally set his browser's preferences to be notified whenever a cookie is stored on his computer. At the end of each browsing session, finally, the user can delete the collected cookies from the hard disk of his device. If he wants to delete the cookies installed in the cookies folder of the browser used, it should be noted that each browser has different procedures for managing settings.

Obligation to provide data

Personal data processed through the installation of technical cookies and first part analytical cookies are necessary to ensure correct navigation within the site. The blockade does not allow the operation of the site.

It is optional to give consent to the installation of third parties analytical cookies and profiling cookies. The user's personal data are processed by the installation of these cookies only with the prior express consent in the manner described above.

Treatment method

Personal data are processed with automated tools for the time strictly necessary to achieve the purposes for which they were collected. Except as specified for navigation data, users / visitors are free to provide their personal data. Failure to provide such data may entail the impossibility of obtaining what has been requested.

Place of data processing

The processing connected to web services mentioned above, takes place at SIGROUP INTERNATIONAL SRL headquarters, Via Mezzabarba 5 / B – 20084 Lacchiarella (MI) by the Data Controller and is only handled by technical staff of the Office in charge of the treatment. No data deriving from the web service is communicated or disseminated.

Personal data provided by users who request information and / or request for sending informative material are used only to perform the service.

Rights of interested parties

Those whose personal data refer have the right at any time to obtain confirmation of the existence or otherwise of such data and to know its content and origin, to verify the accuracy or request the integration of the update, or the correction as well as the right to request cancellation, the transformation into anonymous form or blocking of data processed unlawfully, and to oppose in any case, for legitimate reasons, their treatment.
